NOTICE is hereby given that the Municipality of Cabo Rojo, Puerto Rico is soliciting proposals for Construction Services for *Campo de Soccer Project* - PR-CRP-000518, under the CDBG-DR-City Revitalization Program.

Invitation for Bid (IFB) **documents will be available** at the Office of the Bid Board, Cabo Rojo City Hall, 3rd floor, 49 Betances Street, Cabo Rojo, Puerto Rico, from May 31, 2024. IFB documents can be also requested by email at: juntadesubastas@caborjojpr.net On June 11, 2024, at 10:00 AM, the Municipality will conduct a **pre-bid meeting and site visit** for all interested in submitting a proposal. The meeting will take place at the Mayor's Conference Room, 49 Betances Street, Cabo Rojo, Puerto Rico. All questions or requests for information relating to this IFB shall be submitted via email at juntadesubastas@caborjojpr.net until June 18, 2024, by 11:59 PM.

All proposals must be clearly marked and submitted in identified envelope as follows: "CONSTRUCTION SERVICES FOR CAMPO DE SOCCER PROJECT- PR-CRP-000518" and must be delivered to the Office of the Bid Board, Cabo Rojo City Hall, 49 Betances Street, Cabo Rojo, Puerto Rico, on July 9, 2024, until 1:45 PM. Proposals will be opened at 2:00 PM. at the Mayor's Conference Room. **No email proposals will be accepted**, only hand delivered or certified mail proposals will be considered. The Municipality of Cabo Rojo reserves the right to reject any or all proposals.

IMPORTANT: The proposer acknowledges that all projects funded with Community Development Block Grant Disaster Recovery (CDBG-DR) funds require an environmental review approval from Puerto Rico Department of Housing (PRDOH) certifying officer and/or the U.S. Department of Housing and Urban Development (HUD), according to the level or review required by 24 CFR Part 58. The Autonomous Municipality of Cabo Rojo is responsible for completing the applicable federally required environmental review and, if needed, its request for release of funds, prior to the commencement of any work on the Project in compliance with 24 CFR section 58.22. The Autonomous Municipality of Cabo Rojo will not award a contract or commit any funds to the Project prior to the approval of the federally required environmental review. The proposer has no legal claim to any amount of CDBG-DR funds, or any other source of funds, for the Project until the Autonomous Municipality of Cabo Rojo has obtained the environmental review approval and completed any process required by federal or state regulation. The proposer acknowledges and agrees that neither the Municipality nor PRDOH are responsible for any delays or costs incurred by the proposer as a result of the Municipality's inability to award a contract or commit funds to the Project prior to receiving the environmental review approval.
