#### **Project Location:**

The property is a 3.85-acre site located at Carr. PR-406 Km 3.8 Int. Bo. Anones, the Municipality of Las Marias, Puerto Rico (Parcel ID# 183-000-007-40-000). The proposed project parcel is located at 18.254129, -67.046700. The land was empty and apparently not used prior to the establishment of the current farm. Approximately 2.5 acres of the farm are currently planted with beans, turmeric and galangal. An existing greenhouse is located at 18.254290, -67.04635. The farm is connected to the PREPA electric grid and has a water meter connected to the PRASA. The farm also collects rainwater for bean watering.

#### **Description of the Proposed Project** [24 CFR 58.32; 40 CFR 1508.25]:

The proposed use of grant funds is for the construction of a new greenhouse and the purchase of equipment including chain saw, chipper, Kawasaki mule pole pruner, trimmer, and zero turn mower.

The proposed construction of a new 45-foot by 45-foot greenhouse located south of the existing greenhouse at 18.25393, -67.04624. The site will have to be cleared and graded.

## Statement of Purpose and Need for the Proposal [40 CFR 1508.9(b)]:

The Re-Grow Puerto Rico Urban-Rural Agriculture Program (RGRW) will increase agricultural capacity while promoting and increasing food security island wide. This Program will enhance and expand agricultural production related to economic revitalization and sustainable development activities. The purpose of this project is to increase the productivity of the farm. This agricultural project associated with the construction of a new greenhouse is in keeping with the overall objectives of the Economic Development Program.

## **Existing Conditions and Trends** [24 CFR 58.40(a)]:

The land proposed for the installation of the greenhouse is used for agricultural purposes. Therefore, there is no change in land use associated with the project. Some ground disturbance will be required.

#### Public Outreach [24 CFR 58.43]:

The local community has been very proactive in the recovery process. Puerto Rico Department of Agriculture has worked closely with the agricultural community. The project includes a FONSI / NOI-RROF in compliance with NEPA regulations for HUD.

## Cumulative Impact Analysis [24 CFR 58.32]:

In accordance with 24 CFR 58.32 (Aggregation), there are no cumulative impacts associated with the proposed project. The growth of agricultural products at the farm would not increase. The project would allow more efficient processing of the agricultural products. Water use would increase to a minor degree in the new building but would only impact the existing site water supply. There are no other wells nearby to be affected.

#### **Alternatives** [24 CFR 58.40(e); 40 CFR 1508.9]

The RGRW Program's goal is to increase agricultural capacity while promoting and increasing food security island-wide. This Program seeks to enhance and expand agricultural production related to economic revitalization and sustainable development activities. The applicant submitted a proposal to enhance and expand agricultural production on their property. The proposed use of grant funds will allow the applicant to expand the cultivation, processing, and delivery of agricultural products through the completion of the construction of a new greenhouse and purchase of farm equipment. Any alternative that would involve an off-property location would not enhance and expand agricultural production or allow for the economic development for this applicant. The action is proposed in an area along the existing road between the residence and the existing greenhouse. There would be connection to existing water and power supplies at the residence. Alternative locations on the property would be farther from the road, the electrical supply connection to the residence, and the existing greenhouse.

## No Action Alternative [24 CFR 58.40(e)]:

Under the No Action Alternative, the applicant would not receive federal funding for the completion of construction of a new greenhouse and purchase of new farm equipment which would inhibit the economic growth opportunity that the applicant would not otherwise have under the PRDOH Re-Grow Puerto Rico program. As a result, these owners may not be able to experience the growth needed to recover and expand their agriculture activities. A provision of the grant allows for economic development for businesses. The No-Action alternative would not allow for the economic development for this applicant.

## **Summary of Findings and Conclusions:**

The proposed activity has been found to not have any adverse effects on the environment nor is there the requirement for further consultation with federal agencies associated with the topics evaluated above. There are no environmental review topics addressed above that result in the need for additional formal compliance steps with federal agencies or the requirement for mitigations other than those listed below. There may be additional approvals or permits from local agencies.







Figure 1: PROJECT LOCATION







FIGURE 3: COASTAL BARRIERS IMPROVEMENT ACT






## **FIGURE 4: FLOODPLAIN MANAGEMENT**





#### FIGURE 5: NATIONAL FLOOD HAZARD LAYER FIRMETTE






#### FIGURE 6: COMPARISON OF FLOOD HAZARD







FIGURE 10: NEPASSIST MAP







FIGURE 17: WILD AND SCENIC RIVERS ACT




**FIGURE 18: SLOPE AND EROSION**





includes the greenhouse with coordinates 18.25429° N, -67.04635° W. The farm is connected to the PREPA electric grid and has a water meter connected to the PRASA. The farm also collects rainwater for bean watering. The direct APE includes a 15-meter buffer to all sides. The visual APE is the viewshed of the proposed project.



# Project (Parcel) Location – Area of Potential Effect Map (Aerial)










