Project Location:

The property is a 13.73-acre site located at Carr. PR-185 Km 15.7, Bo. Cedro in the Municipality of Carolina, Puerto Rico (Parcel ID # 200-000-002-70-000). The proposed project sites are located north and west of the residence at 18.275887, -65.913053.

Description of the Proposed Project [24 CFR 58.32; 40 CFR 1508.25]:

The proposed use of grant funds is for the construction of three 100-foot by 30-foot greenhouses and installation of a water supply well. Two of the greenhouses would be constructed side by side on a 140-foot by 100-foot terrace located northwest of the residence at 18.2764318, -65.9134952. Another greenhouse would be constructed on a approximately 170-foot by 50-foot terrace located west of the residence at 18.27577, -65.91444.

The project includes drilling a 500' deep water well located to the north of the residence at 18.27632, -65.91307. The installation of the well would include an electric pump and connection to electric supply. The applicant indicates that he holds a permit for the well from the Department of Natural and Environmental Resources of Puerto Rico.

These activities will require ground disturbance. The areas were previously cleared and graded as part of farming operations.

Previously used as a coffee plantation, the land at Hacienda Rexel is currently used for cocoa and plantain cultivation.

Statement of Purpose and Need for the Proposal [40 CFR 1508.9(b)]:

The Re-Grow Puerto Rico Urban-Rural Agriculture Program (RGRW) will increase agricultural capacity while promoting and increasing food security island-wide. This Program will enhance and expand agricultural production related to economic revitalization and sustainable development activities. This agricultural project associated with the construction of new greenhouses and water well is in keeping with the overall objectives of the Economic Development Program.

Existing Conditions and Trends [24 CFR 58.40(a)]:

The proposed project site is on an existing farm. The ground clearing in the project area has already been completed. The proposed action would not result in any change in land use.

Public Outreach [24 CFR 58.43]:

The local community has been very proactive in the recovery process. Puerto Rico Department of Agriculture has worked closely with the agricultural community. The project includes a FONSI / NOI-RROF in compliance with NEPA regulations for HUD.

Cumulative Impact Analysis [24 CFR 58.32]:

In accordance with 24 CFR 58.32 (Aggregation), there are no cumulative impacts associated with the proposed project. The agricultural activities at the farm would increase to a minor degree above current levels due to the implementation of the project. Water use would increase to a minor degree but would only impact the existing farm well. There are no other wells nearby to be affected.

Alternatives [24 CFR 58.40(e); 40 CFR 1508.9]

The RGRW Program's goal is to increase agricultural capacity while promoting and increasing food security island-wide. This Program seeks to enhance and expand agricultural production related to economic revitalization and sustainable development activities. The applicant submitted a proposal to enhance and expand agricultural production on their property. The proposed use of grant funds will allow the applicant to expand the cultivation of plantains in the new greenhouses and through use of the expanded water supply from the new water supply well. Any alternative that would involve an off-property location would not enhance and expand agricultural production or allow for this economic development for this applicant. The actions are proposed in areas close to the farm residence that has been previously cleared and graded as part of farming operations. Alternative locations on the property would be farther from the farm residence and would require additional tree removal and grading.

No Action Alternative [24 CFR 58.40(e)]:

Under the No Action Alternative, the applicant would not receive federal funding for the construction of three greenhouses and the installation of a new water supply well which would inhibit the economic growth opportunity that the applicant would not otherwise have under the PRDOH Re-Grow Puerto Rico program. As a result, these owners may not be able to experience the growth needed to recover and expand their agriculture activities. A provision of the grant allows for economic development for businesses. The No-Action alternative would not allow for the economic development for this applicant.

Summary of Findings and Conclusions:

The proposed activity has been found to have no adverse effects on the environment nor is there the requirement for further consultation with any agency. There are no environmental review topics addressed that result in the need for formal compliance steps or the requirement for mitigation.

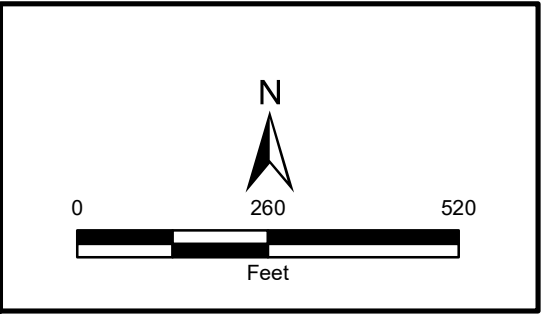


FIGURE 1: PROJECT LOCATION

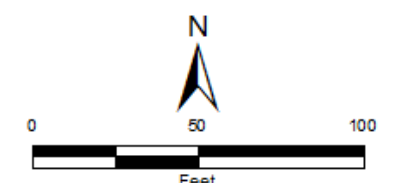
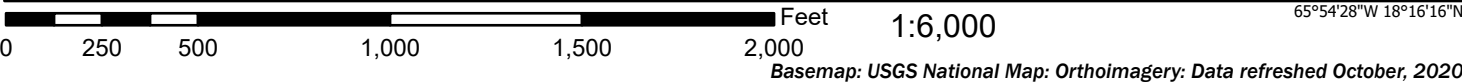
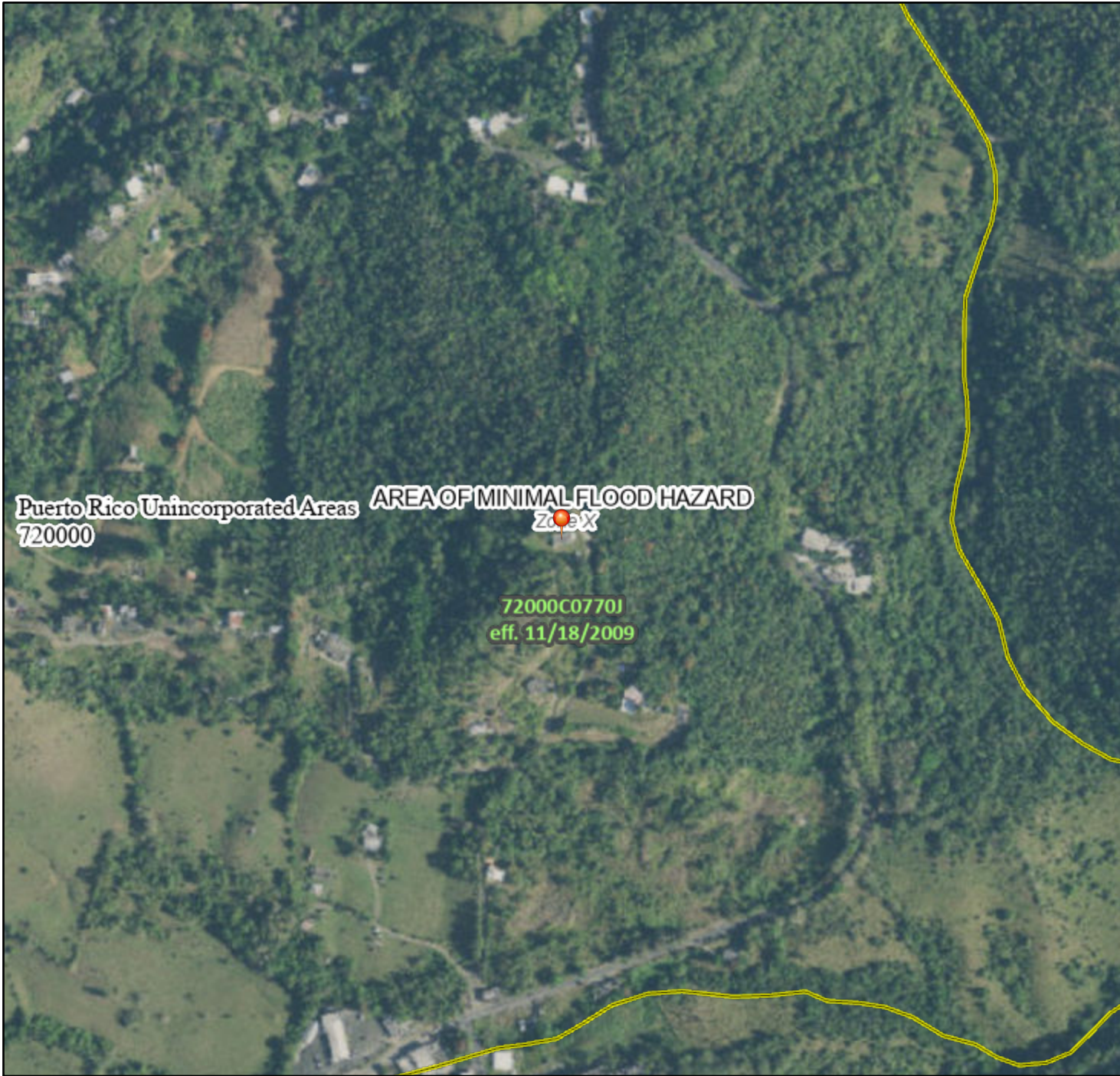


FIGURE 5: National Flood Hazard Layer FIRMette

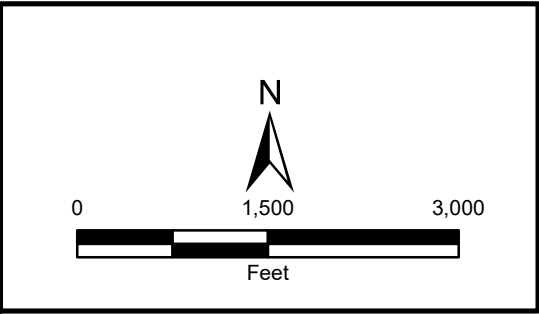


FIGURE 8: TOXIC CHEMICALS AND GASES, HAZARDOUS MATERIALS, CONTAMINATION, AND RADIOACTIVE SUBSTANCES

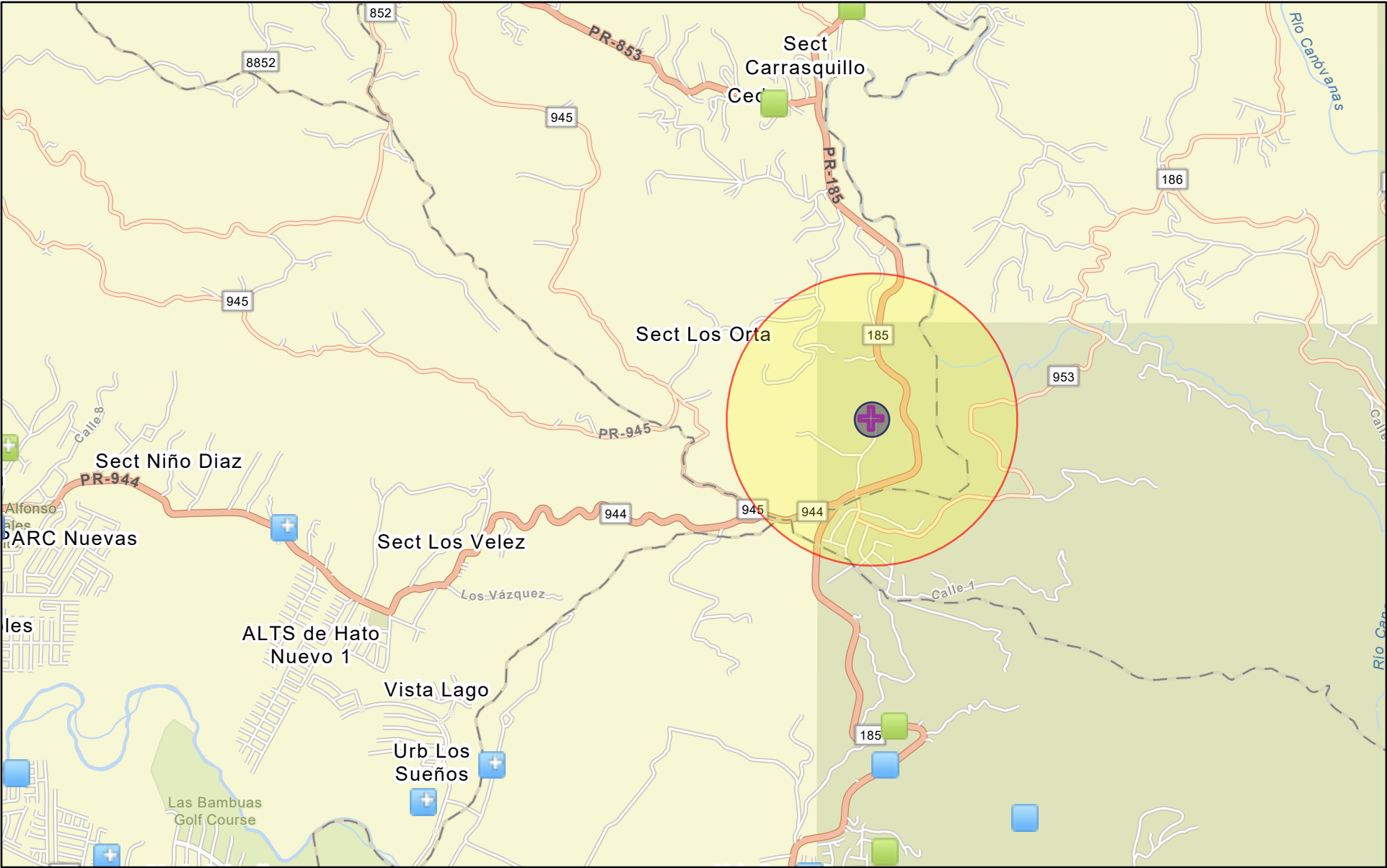



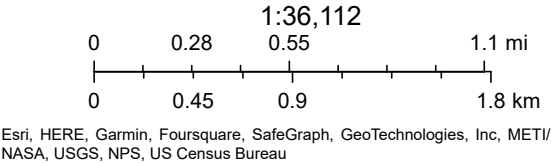
FIGURE 9: NEPAssist Map

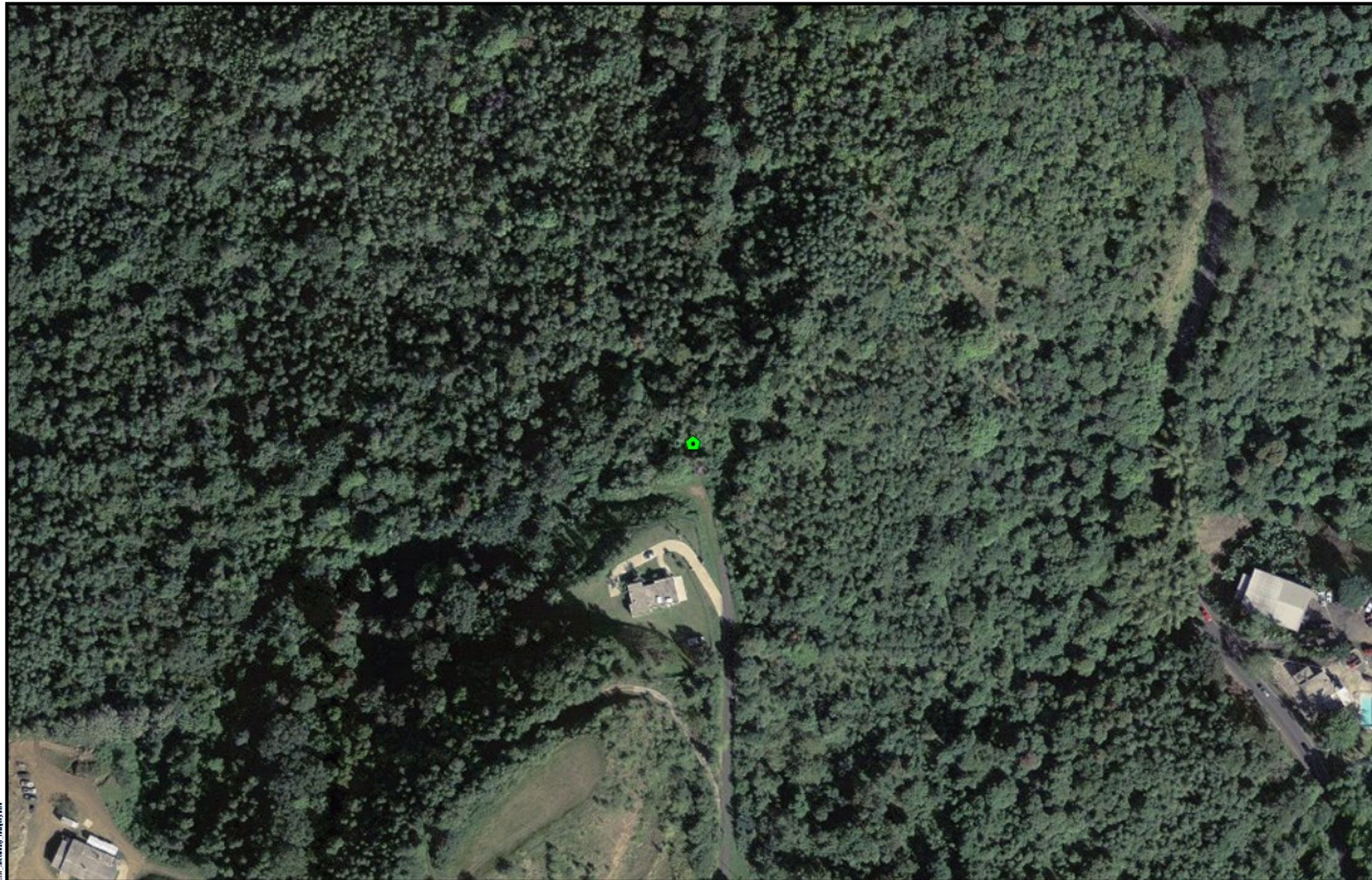

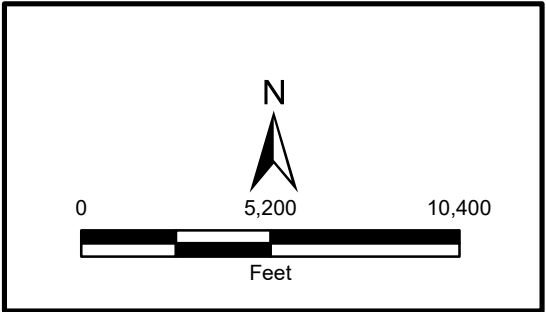
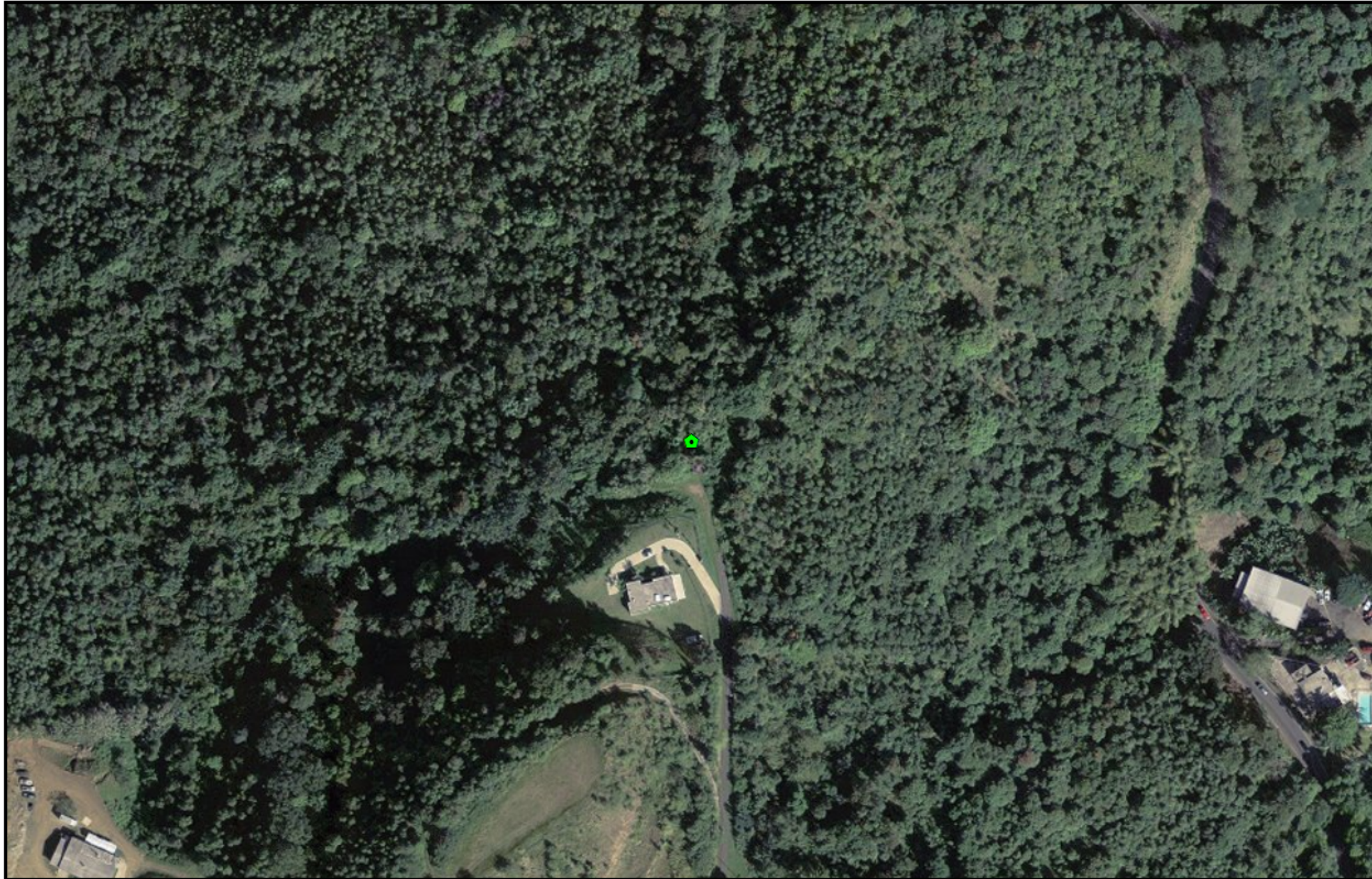


FIGURE 11: CRITICAL HABITAT



FIGURE 12: FARMLAND PROTECTION

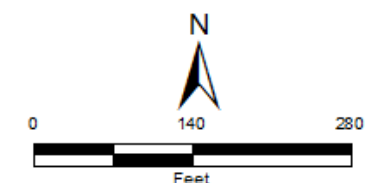

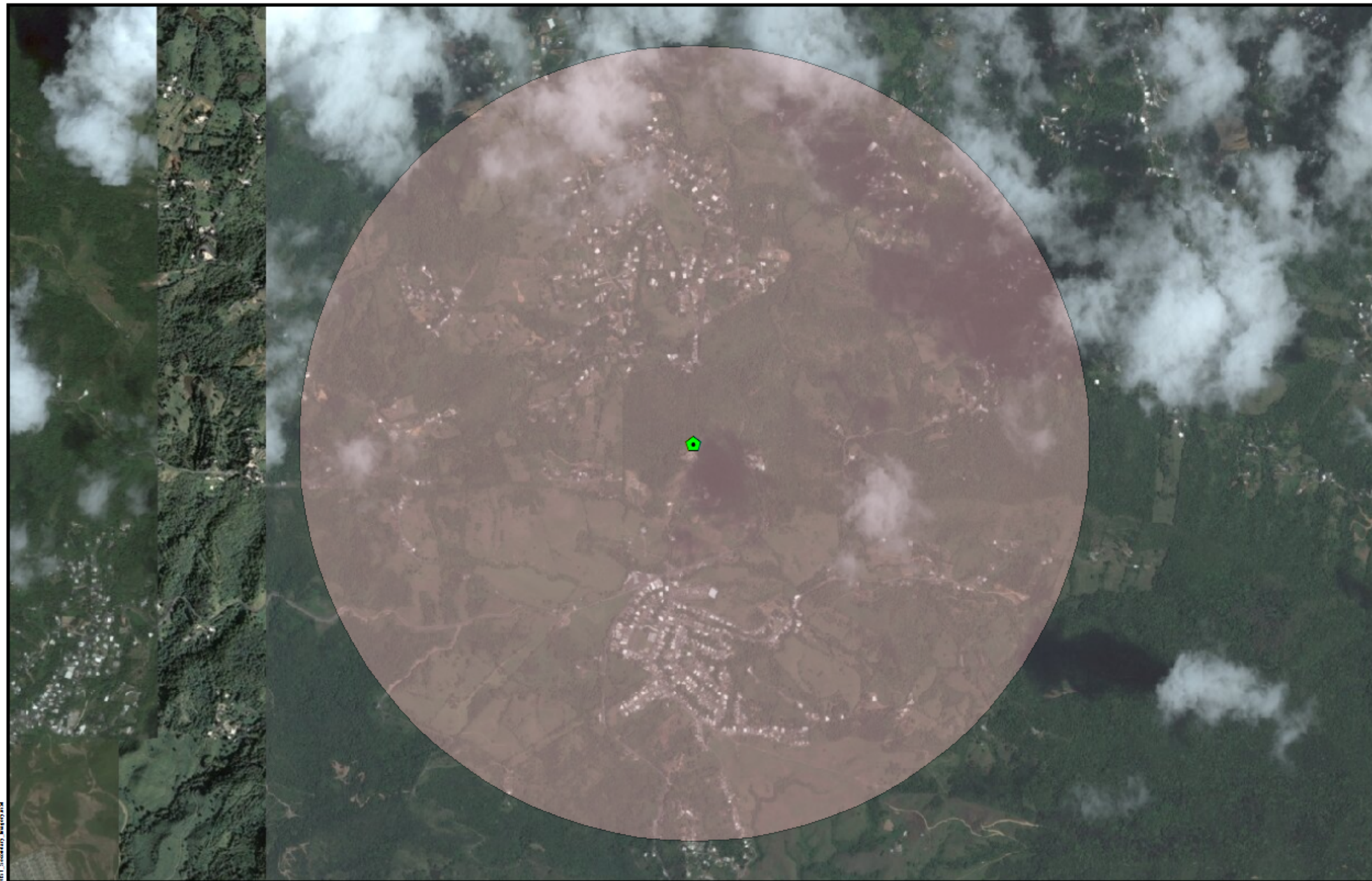

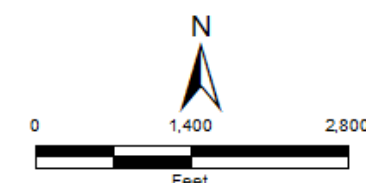
FIGURE 13: HISTORIC PRESERVATION

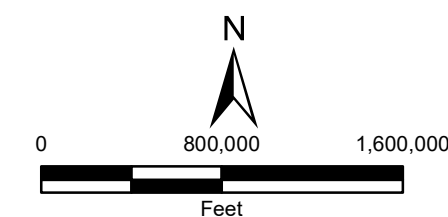

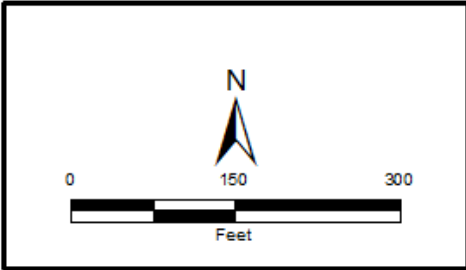


FIGURE 15: WETLANDS

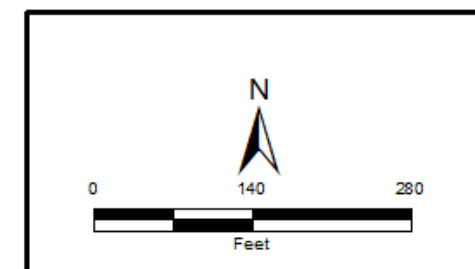

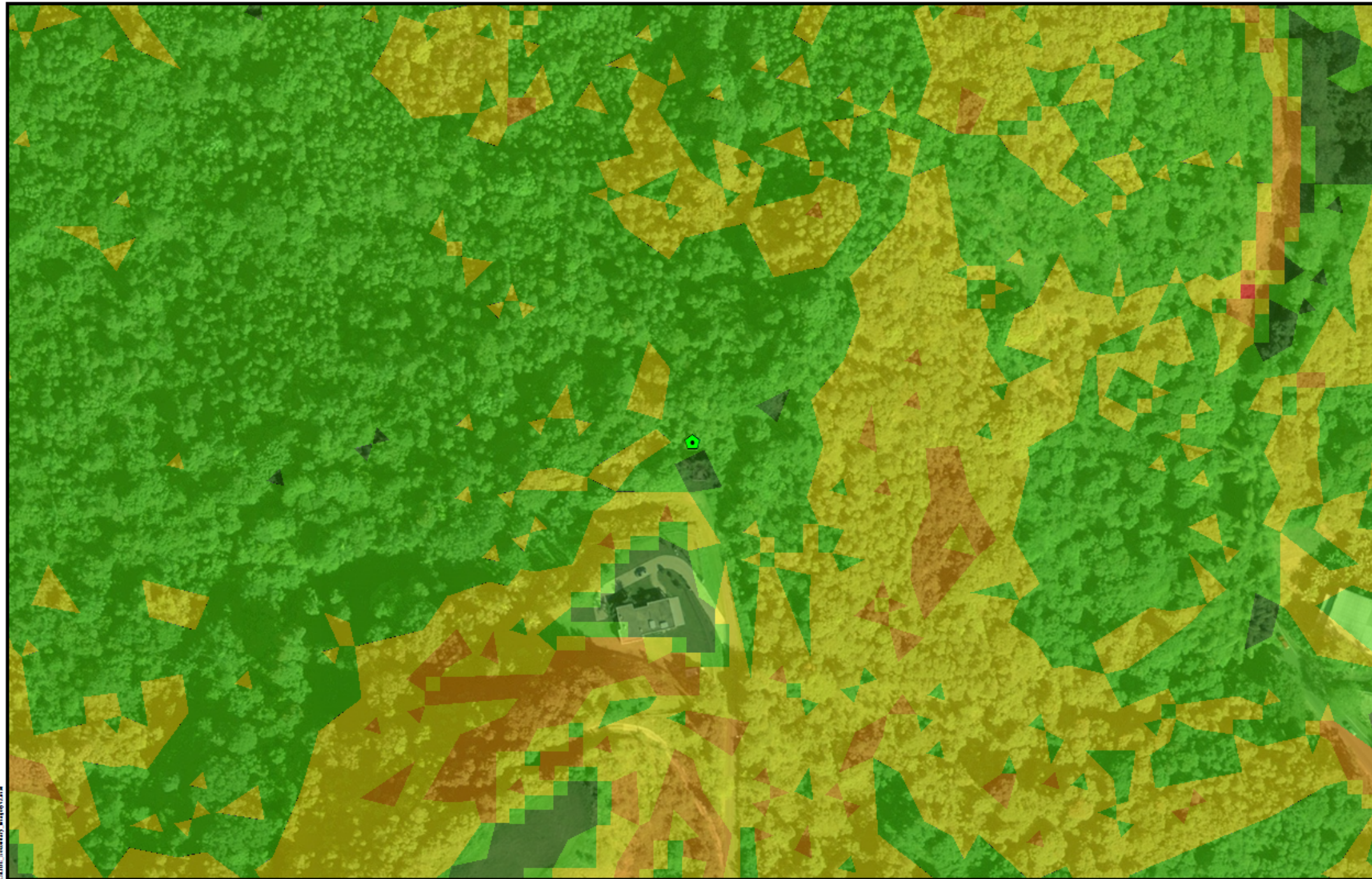

FIGURE 17: SLOPE AND EROSION

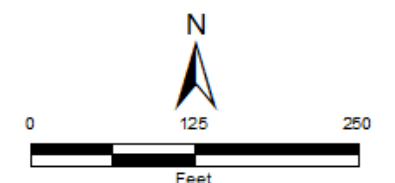



The property is located at Carretera PR-185 Km 15.7, at Bo. Cedro, Municipality of Carolina. Previously used as a coffee plantation, the land at Hacienda Raxel is currently used for plantain cultivation.

Area of Potential Effects

As defined in 36 CFR §800.16(d), the area of potential effects (APE) is the geographic area or areas within which an undertaking may directly or indirectly cause changes in the character or use of historic properties if any such properties exist. Based on this definition and the nature and scope of the Undertaking, the Program has determined that the direct APE for this project includes a 500' deep well at 8.27632, -65.91307, to be driven by electric power, and two 100' by 30' plots for greenhouses located side by side. The first greenhouse is 100' by 30' wide, located on a terrace approximately 140' long by 100' wide. The second greenhouse is also 100' by 30' wide, and located on a terrace approximately 170' long by 50' wide. The direct APE includes a 15-meter buffer to the rear and sides. 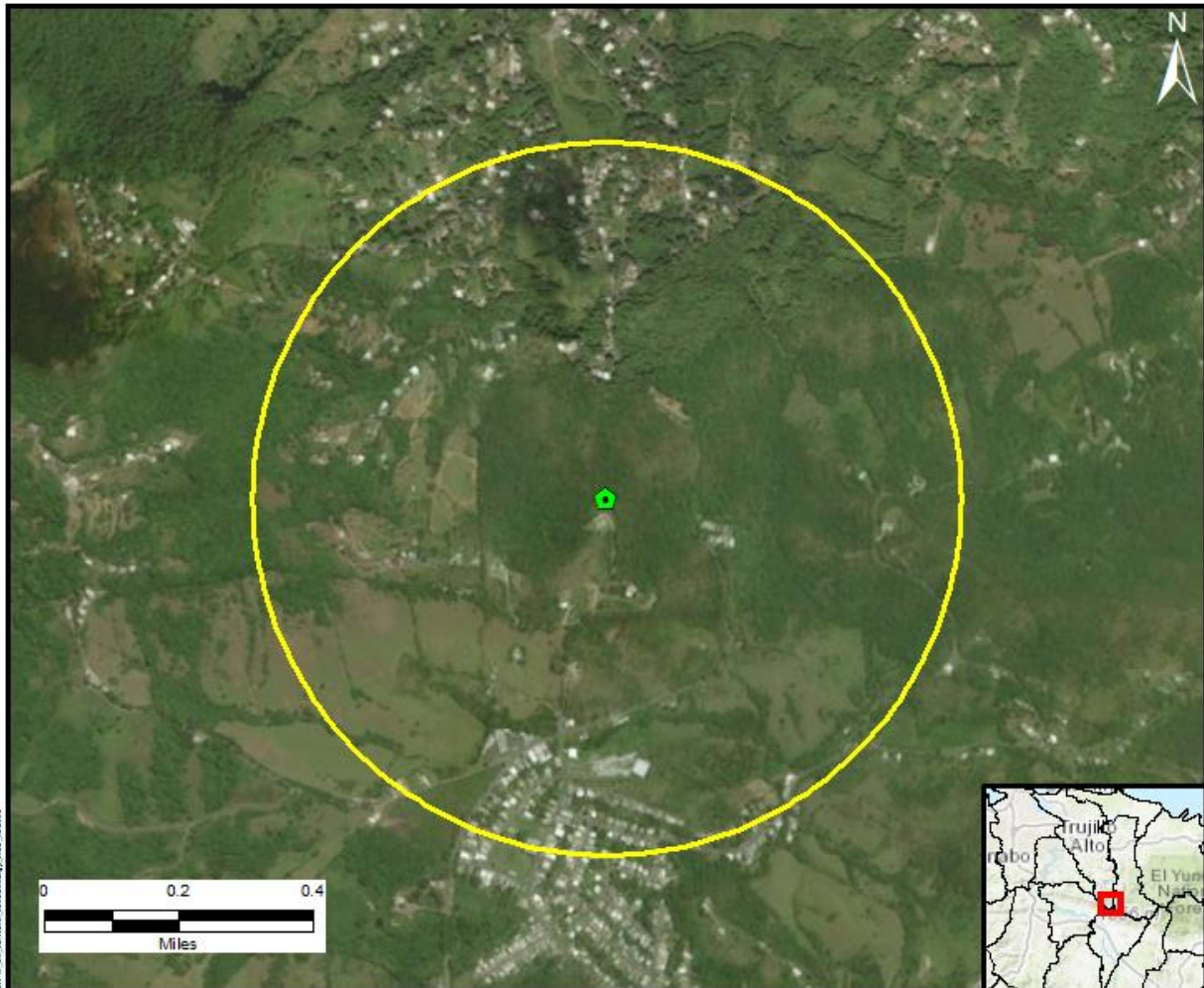

Dear Arch. Rubio Cancela:

The U.S. Department of Housing (HUD) approved the allocations of Community Development Block Grant (CDBG-DR) funds on February 9, 2018. It also approved the allocation of Community Development Block Grant Mitigation (CDBG-MIT) funds on January 27, 2020. The purpose of these allocations is to address unsatisfied needs as a result of Hurricanes Irma and Maria in September 2017; and to carry out strategic and high-impact activities to mitigate disaster risks and reduce future losses.

To comply with the environmental requirements established by HUD, the Department of Housing of Puerto Rico (PRDOH) contracted Horne Federal LLC to provide environmental registry review services, among others, that will support the objectives of the agenda for both CDBG-DR and CDBG -MIT Programs.

In line to expedite the processes, Horne Federal LLC, is authorized to submit to the State Historic Preservation Officer, documentation of projects related to both the CDBG-DR and CDBG-MIT on behalf of PRDOH.
