This project (PR-RGRW-01875-W) entails the award of a grant to Sierra Nativa Corp., an agricultural business, at Urb. Hacienda Grande Calle Casia Solar 19, Naguabo, PR 00718. Tax ID Number: 230-000-009-05-901. Coordinates (latitude 18.2193463, longitude -65.7115161). The intended use of funds for the proposed project is the purchase of a plow, sprayer, water tank, electric generator, rotary cutter, tractor, UTV, fencing materials, digging bucket tractor attachment, and the purchase and installation of a new greenhouse. Ground disturbance activities will be required for the construction of the new greenhouse, the installation of the electric generator, the installation of the water tank, and the preparation of the new plantains and vegetable cropping areas, including the installation of cropping area delimitation fence. The Scope of Work 1 (SOW-1) is the installation of a "High Tunnel" greenhouse at coordinates 18.2194575, -65.7112871. The proposed greenhouse is an approximately 50-foot (ft)' x 30 ft galvanized metal structure and will be anchored to the ground with 2 inches diameter pillars. The Scope of Work 2 (SOW-2) is the purchase and installation of a 13 KW electric generator at coordinates 18.2192896, -65.7113853. The applicant plans to install the generator on a dike like system to be constructed on-site. The dike consists of an on-site concrete poured pad of approximately 8 ft x 10 ft and block containment walls of 1 ft of height. The Scope of Work 3 (SOW-3) is the purchase and installation of a 5,000-gallon water tank at coordinates 18.2193107, -65.7114092. The tank will be installed on a 10 ft x 10 ft poured concrete pad to be constructed. The Scope of Work 4 (SOW-4) includes the preparation of the new plantains and vegetables cropping areas located at 18.2197820, -65.7121022 and 18.2191683, -65.7108489, in areas that appear not to have been previously cultivated. The SOW for the preparation of the cropping areas consists of the installation of wood posts and barbed wire fence (farming materials) to protect and prevent crop damage caused by animal invasion. The fences will be constructed with 3 x 6 1/2 wood posts at a depth of 2 feet. At least 900 posts will be installed. The SOW for the project does not include any power or water utility connection. 



This memorandum is to notify the Re-Grow PR Urban-Rural Agriculture Program (Re-Grow Program) that on October 10, 2024, for the case **PR-RGRW-01875**, the CDBG-DR/MIT Permits and Environmental Compliance Division submitted an informal consultation under Section 7 (a)(2) of the Endangered Species Act (Act) (87 Stat. 884, as amended; 16 United States Code 1531 et seq.), and in accordance with the Fish and Wildlife Coordination Act (47 Stat. 401, as amended; 16 U.S.C. 661 et seq.) for the proposed project, which consists of the four scopes of work (SOW) within the parcel. SOW-1 is the installation of a "High Tunnel" greenhouse. SOW-2 is the purchase and installation of a 13KW electric generator. SOW-3 is the purchase and installation of a 5,000-gallon water tank. SOW-4 includes the preparation of the new plantains and vegetables cropping areas. Sierra Nativa Corp., an agricultural business, located PR-187 Km. 4.0, Hacienda Grande Ward, 19 Sector, Casia Street, Naguabo, PR 00718; latitude 18.219624, longitude -65.711942.

Using the Information for Planning and Consultation (IPaC) system, the proponent has determined that the proposed project lies within the range of the following federally listed species:

The United States Fish and Wildlife Service (USFWS) Caribbean Ecological Services Field Office reviewed the information provided and their files, and on December 23, 2024, concurred with the determination that the proposed project actions **May Affect, but is Not Likely to Adversely Affect (NLAA)** the Puerto Rican Boa.

The USFWS NLAA concurrence is conditioned to the following: (1) if a Boa is encountered, the Conservation Measures will be in accordance with the USFWS Puerto Rican Boa Conservation Measures 2024.

Obligations under section 7 of the Act must be reconsidered if: (1) new information reveals impacts of this identified action that may affect listed species or critical habitat in a manner that was not previously considered; (2) this action is subsequently modified in a manner not previously considered in this assessment; or, (3) a new species is listed, or critical habitat determined that may be affected by the identified action.

In conclusion, the USFWS concurred with the CDBG-DR/MIT Permits and Environmental Compliance Division NLAA determination. However, **the applicant must be informed about the conditions of the determination of concurrence and implement them as described.**



Conservation Measures for the Puerto Rican boa (*Chilabothrus inornatus*)

Section 7 (a)(1) of the Endangered Species Act (ESA) charges Federal agencies to aid in the conservation of listed species, and section 7 (a)(2) requires the agencies, through consultation with the U.S. Fish and Wildlife Service (Service), to ensure their activities are not likely to jeopardize the continued existence of listed species or adversely modify designated critical habitats. Section 7 applies to the management of Federal lands as well as Federal actions that may affect federally listed species, such as Federal approval of private activities through the issuance of Federal funding, permits, licenses, or other actions. Any person that injures, captures, or kills a Puerto Rico boa is subject to penalties under the ESA. If Federal funds or permits are needed, the funding or permitting agency should initiate Section 7 consultation with the Service. To initiate a consultation under the Section 7 of the ESA, you must submit a project package with the established minimum requirements. These conservation measures should be incorporated into the project plans to minimize possible impacts to the species.

The endangered Puerto Rican (PR) boa (*Chilabothrus inornatus*, formerly *Epicrates inornatus*) is the largest endemic snake species that inhabits Puerto Rico. The PR boa is non-venomous and does not pose any life threatening danger to humans, but some individuals may try to bite if disturbed or during capture or handling. Its body color ranges from tan to dark brown with irregular diffuse marking on the dorsum, but some individuals lack marking and are uniformly dark. Juveniles may have a reddish color with more pronounced markings. In general, as they mature, their body color tends to darken.



The PR boa was federally listed in 1970. Currently, the species has an island-wide distribution and occurs in a wide variety of habitat types, ranging from wet montane to subtropical dry forest and can be found from mature forest to areas with different degrees of human disturbance such as roadsides or houses, especially if near their habitat in rural areas. The PR boa is considered mostly nocturnal, remaining less active, concealed or basking under the sun during the day.

The Service has developed the following conservation measures with the purpose of assisting others to avoid or minimize adverse effects to the PR boa and its habitat. These recommendations may be incorporated into new project plans and under certain circumstances into existing projects. Depending on the project, additional conservation measures can be implemented besides the ones presented in this document.

Conservation Measures:

1. Inform all project personnel about the potential presence of the PR boa in areas where the proposed work will be conducted. A pre-construction meeting should be conducted to inform all project personnel about the need to avoid harming the species as well as penalties for harassing or harming PR boas. An educational poster or sign with photo or illustration of the species should be displayed at the project site.
2. Prior to any construction activity, including removal of vegetation and earth movements, the boundaries of the project and areas to be excluded and protected should be clearly marked in the project plan and in the field in order to avoid further habitat degradation into forested and conservation areas.
3. Once areas are clearly marked, and prior to the use of heavy machinery and any construction activity (including removal of vegetation and earth movement), a biologist or project personnel with experience on this species should survey the areas to be cleared to verify the presence of any PR boa within the work area.
4. If a PR boa is found within any of the working or construction areas, activities should stop at that area and information recorded (see #5). **Do not capture the boa.** If boas need to be moved out of harm's way, designated personnel shall immediately contact the Puerto Rico Department of Natural and Environmental Resources (PRDNER) Rangers for safe capture and relocation of the animal (PRDNER phone #s: (787) 724-5700, (787) 230-5550, (787) 771-1124). **If immediate relocation is not an option, project-related activities at that area must stop until the boa moves out of harm's way on its own.** Activities at other work sites, where no boas have been found after surveying the area, may continue.
5. For all boa sightings (dead or alive), record the time and date of the sighting and the specific location where it was found. PR boa data should also include a photo of the animal (dead or alive), site GPS coordinates, the time and date, and comments on how the animal was detected and its behavior.

6. If a PR boa is captured by PRDNER personnel, record the name of that person and information on where the PR boa will be taken. This information should be reported to the Service.
7. Measures should be taken to avoid and minimize PR boa casualties by heavy machinery or motor vehicles being used on site. Any heavy machinery left on site (staging) or near potential PR boa habitat (within 50 meters of potential boa habitat), needs to be thoroughly inspected each morning before work starts to ensure that no boas have sheltered within engine compartments or other areas of the equipment. If PR boas are found within vehicles or equipment, do not capture the animal, and let it move on its own or call PRDNER Rangers for safe capture and relocation of the animal (see #4). If not possible, the animal should be left alone until it leaves the vehicle on its own.
8. PR boas may seek shelter in debris piles. Measures should be taken to avoid and minimize boa casualties associated with sheltering in debris piles as a result of project activities. Debris piles should be placed far away from forested areas. Prior to moving, disposing or shredding, debris piles should be carefully inspected for the presence of boas. If debris piles will be left on site, we recommend they be placed in areas that will not be disturbed in the future.
9. If a dead PR boa is found, immediately cease all work in that area and record the information accordingly (see #5). If the PR boa was accidentally killed as part of the project actions, please include information on what conservation measures had been implemented and what actions will be taken to avoid further killings. A dead boa report should be sent by email (see contacts below) to the Service within 48 hours of the event.

The Puerto Rico Department of Housing (PRDOH) is requesting an informal consultation under Section 7 (a)(2) of the Endangered Species Act (Act) (87 Stat. 884, as amended; 16 United States Code 1531 et seq.), and in accordance with the Fish and Wildlife Coordination Act (47 Stat. 401, as amended; 16 U.S.C. 661 et seq.) for the proposed project PR-RGRW-01875, located at Hacienda Grande Neighborhood, Casia Street, Solar 19, Naguabo, PR 00718 (Parcel ID# 230-000-009-05).

The project is part of the Re-Grow Puerto Rico Urban-Rural Agriculture Program (RGRW) that aims to increase agricultural capacity while promoting and increasing food security island wide. This Program will enhance and expand agricultural production related to economic revitalization and sustainable development activities.

The proposed project, PR-RGRW-01875, consists of four scopes of work (SOW) within the parcel. SOW-1 is the installation of a "High Tunnel" greenhouse at coordinates 18.2194575, -65.7112871. The proposed greenhouse is an approximately 50-foot x 30-foot galvanized metal structure with six mils plastic membrane and Saran cover to be used for seeding of vegetables such as culantro, cilantrillo, recaó, sweet peppers, and spinach, in tables. The structure includes a rain harvesting system that will be used for the irrigation of vegetable crops. The greenhouse will be anchored to the ground with 2-inch diameter pillars. The greenhouse front and side pillars are reinforced by a ratchet fixed to the ground to a maximum depth of 3 feet and attached to the top of each pillar with galvanized cord. Lateral and central pillar spacing varies depending on the greenhouse size. For the proposed greenhouse lateral and central pillar spacing is 8 feet. The proposed greenhouse will require up to 22 posts.

SOW-2 is the purchase and installation of a 13KW electric generator at coordinates 18.2192896, -65.7113853. The applicant plans to install the generator on a dike-like system to be constructed on site. The dike consists of an on-site concrete poured pad of approximately 8 feet x 10 feet, and block containment walls of 1-foot height. The thickness of the concrete pad should be 4-6 inches for a ground disturbance of up to 1-foot depth. Installation of generator includes the installation of an automatic transfer switch and up to 30 lineal feet of a basic aboveground electrical conduit for power connection.

SOW-3 is the purchase and installation of a 5,000-gallon water tank at coordinates 18.2193107, -65.7114092. The tank will be installed on a 10-foot x 10-foot poured concrete pad to be constructed. The thickness of the concrete pad should be 8-10 inches for a ground disturbance of up to 1.5-foot depth. The tank will collect rainwater and provide irrigation water to the vegetables crops via an aboveground PVC piping system to be installed. Water will convey via gravity due to difference in elevations.

SOW-4 includes the preparation of the new plantains and vegetables cropping areas located at 18.2197820, -65.7121022 (A – plantains crop) / 18.2191683, -65.7108489 (B – vegetables crop), in areas that appear not to have been previously cultivated. The SOW for the preparation of the cropping areas includes the installation of a wood posts and barb wire fence (farming materials) to protect and prevent crop damage caused by animal invasion. The fences will be constructed with 3" x 6½' wood posts at a depth of 2 foot. At least 900 posts will be installed. The area is planned to be used for the growing of cilantrillo, culantro, coriander, recaó, and sweet peppers.

A review of historic aerial imagery failed to identify any evidence of previous cultivation. As previously noted, the area appears to have been utilized for cattle grazing for much of the twentieth century. The activities include the purchase and use of plow, rotary cutter, tractor, 4x4 UTV, sprayer, and the digging bucket tractor. The SOW for the project does not include any power or water utility connection to local services utilities provided by PRASA or PREPA/LUMA. The rain harvesting system to be installed with the greenhouse will be used as the source of water for the irrigation of the vegetables cropping area via an aboveground PVC distribution system. Generator will provide power needed for the operations of the greenhouse and farm activities. The installation of the generator includes 30 lineal feet of a basic aboveground electrical conduit for power connection. Field is not graded. The project site will require clearing, grubbing, grading, and some vegetation removal. However, the proposal does not contemplate cutting, pruning, or transplanting of trees. The National Wetlands Inventory indicated that no wetlands are located within the proposed project area.

Using the Information for Planning and Consultation (IPaC) system, we have determined that the proposed project lies within the range of the following federally listed species:

Based on site review and site photos, no suitable habitat was found within the proposed project area for the listed species.

The Puerto Rican Boa habitat requirements per the U.S. Fish and Wildlife Service are as follows: "The Puerto Rican Boa is considered a habitat generalist and tolerates a wide variety of habitat types (terrestrial and arboreal). These include: rocky areas and haystack hills, trees and branches, rotting stumps, caves (entrances and inside), plantations, various types of forested areas such as karst and mangrove forests, forested urban and rural areas, and along streams and road edges. Cave ecosystems and their surrounding forests are considered particularly important because of the availability of such ecological resources such as prey, shelter, thermal gradients, and mates for reproduction."

Based on the nature of the project, previous site disturbance, scope of work, information available, and a careful analysis of the Project Site, and IPaC species list, we have made the following effects determinations:



On September 24, 2024, Shelby McDowell used the Caribbean DKey; dated April 03, 2024, in the U.S. Fish and Wildlife Service's online [IPaC application](#) to evaluate potential impacts to federally listed species, from a project named 'PR-RGRW-01875'. 





Conservation Measures for the Puerto Rican boa (*Chilabothrus inornatus*)

Section 7 (a)(1) of the Endangered Species Act (ESA) charges Federal agencies to aid in the conservation of listed species, and section 7 (a)(2) requires the agencies, through consultation with the U.S. Fish and Wildlife Service (Service), to ensure their activities are not likely to jeopardize the continued existence of listed species or adversely modify designated critical habitats. Section 7 applies to the management of Federal lands as well as Federal actions that may affect federally listed species, such as Federal approval of private activities through the issuance of Federal funding, permits, licenses, or other actions. Any person that injures, captures, or kills a Puerto Rico boa is subject to penalties under the ESA. If Federal funds or permits are needed, the funding or permitting agency should initiate Section 7 consultation with the Service. To initiate a consultation under the Section 7 of the ESA, you must submit a project package with the established minimum requirements. These conservation measures should be incorporated into the project plans to minimize possible impacts to the species.

The endangered Puerto Rican (PR) boa (*Chilabothrus inornatus*, formerly *Epicrates inornatus*) is the largest endemic snake species that inhabits Puerto Rico. The PR boa is non-venomous and does not pose any life threatening danger to humans, but some individuals may try to bite if disturbed or during capture or handling. Its body color ranges from tan to dark brown with irregular diffuse marking on the dorsum, but some individuals lack marking and are uniformly dark. Juveniles may have a reddish color with more pronounced markings. In general, as they mature, their body color tends to darken.



The PR boa was federally listed in 1970. Currently, the species has an island-wide distribution and occurs in a wide variety of habitat types, ranging from wet montane to subtropical dry forest and can be found from mature forest to areas with different degrees of human disturbance such as roadsides or houses, especially if near their habitat in rural areas. The PR boa is considered mostly nocturnal, remaining less active, concealed or basking under the sun during the day.

The Service has developed the following conservation measures with the purpose of assisting others to avoid or minimize adverse effects to the PR boa and its habitat. These recommendations may be incorporated into new project plans and under certain circumstances into existing projects. Depending on the project, additional conservation measures can be implemented besides the ones presented in this document.

Conservation Measures:

1. Inform all project personnel about the potential presence of the PR boa in areas where the proposed work will be conducted. A pre-construction meeting should be conducted to inform all project personnel about the need to avoid harming the species as well as penalties for harassing or harming PR boas. An educational poster or sign with photo or illustration of the species should be displayed at the project site.
2. Prior to any construction activity, including removal of vegetation and earth movements, the boundaries of the project and areas to be excluded and protected should be clearly marked in the project plan and in the field in order to avoid further habitat degradation into forested and conservation areas.
3. Once areas are clearly marked, and prior to the use of heavy machinery and any construction activity (including removal of vegetation and earth movement), a biologist or project personnel with experience on this species should survey the areas to be cleared to verify the presence of any PR boa within the work area.
4. If a PR boa is found within any of the working or construction areas, activities should stop at that area and information recorded (see #5). **Do not capture the boa.** If boas need to be moved out of harm's way, designated personnel shall immediately contact the Puerto Rico Department of Natural and Environmental Resources (PRDNER) Rangers for safe capture and relocation of the animal: (787) 999-2200 ext. 2911. **If immediate relocation is not an option, project-related activities at that area must stop until the boa moves out of harm's way on its own.** Activities at other work sites, where no boas have been found after surveying the area, may continue.
5. For all boa sightings (dead or alive), record the time and date of the sighting and the specific location where it was found. PR boa data should also include a photo of the animal (dead or alive), site GPS coordinates, the time and date, and comments on how the animal was detected and its behavior.

6. If a PR boa is captured by PRDNER personnel, record the name of that person and information on where the PR boa will be taken. This information should be reported to the Service.
7. Measures should be taken to avoid and minimize PR boa casualties by heavy machinery or motor vehicles being used on site. Any heavy machinery left on site (staging) or near potential PR boa habitat (within 50 meters of potential boa habitat), needs to be thoroughly inspected each morning before work starts to ensure that no boas have sheltered within engine compartments or other areas of the equipment. If PR boas are found within vehicles or equipment, do not capture the animal, and let it move on its own or call PRDNER Rangers for safe capture and relocation of the animal (see #4). If not possible, the animal should be left alone until it leaves the vehicle on its own.
8. PR boas may seek shelter in debris piles. Measures should be taken to avoid and minimize boa casualties associated with sheltering in debris piles as a result of project activities. Debris piles should be placed far away from forested areas. Prior to moving, disposing or shredding, debris piles should be carefully inspected for the presence of boas. If debris piles will be left on site, we recommend they be placed in areas that will not be disturbed in the future.
9. If a dead PR boa is found, immediately cease all work in that area and record the information accordingly (see #5). If the PR boa was accidentally killed as part of the project actions, please include information on what conservation measures had been implemented and what actions will be taken to avoid further killings. A dead boa report should be sent by email (see contacts below) to the Service within 48 hours of the event.
10. Projects must comply with all state laws and regulations. Please contact the PRDNER for further guidance.

In accordance with Section 106 of the National Historic Preservation Act and its implementing regulations, 36 CFR Part 800, HORNE is providing information for your review and requesting your concurrence regarding the above-referenced projects on behalf of the Puerto Rico Department of Housing (PRDOH). On February 9, 2018, an allocation of Community Development Block Grant - Disaster Recovery (CDBG-DR) funds were approved by the United States Department of Housing and Urban Development (HUD) under the Federal Register Volume 83, No. 28, 83 FR 5844, to assist the Commonwealth of Puerto Rico in meeting unmet needs in the wake of Hurricanes Irma and Maria. On August 14, 2018, an additional \$8.22 billion recovery allocation was allocated to Puerto Rico under the Federal Register Volume 83, No. 157, 83 FR 40314. With these funding allocations, the Puerto Rico Department of Housing (Housing) aims to lead a comprehensive and transparent recovery for the benefit of Puerto Rico residents.

Consultation was originally initiated for case PR-RGRW-01875 on March 26, 2024, on behalf of the Puerto Rico Department of Housing (PRDOH) and the subrecipient. The undertaking consisted of the purchase of a plow, water tank, electric generator, rotary cutter, tractor, digging bucket tractor attachment, and the purchase and installation of a new greenhouse. In a letter dated April 6, 2024, the Puerto Rico State Historic Preservation Office supported PRDOH's finding of No Historic Properties Affected. Since that time, it was discovered that the original consultation omitted the installation of a barbed-wire fence in SOW-4, which will be installed around the planting areas. Therefore, the Area of Potential Effect has been revised to include the proposed fencing in SOW-4. The full scope of the project, which includes revised mapping and photographs, is described in the submitted documentation.

Based on the provided documentation, the Program requests a concurrence with a determination that **no historic properties affected** are appropriate for this undertaking.

In compliance with Section 106 of the National Historic Preservation Act (NHPA), the Program is responsible for identifying historic properties listed in the NRHP and any properties not listed that would be considered eligible for listing that are located within the geographic area of potential effects (APE) of the proposed project and assessing the potential effects of its undertakings on these historic properties.

Previous Consultation

Consultation was initiated on March 26, 2024, on behalf of PRDOH and the subrecipient, the Puerto Rico Department of Agriculture, and Sierra Nativa Corp. for the undertaking of this project that includes the purchase of a plow, water tank, electric generator, rotary cutter, tractor, digging bucket tractor attachment, and the purchase and installation of a new greenhouse at the property located at Urb. Hacienda Grande Calle Casia Solar 19, in the municipality of Naguabo (SHPO-CF-03-26-24-12). The PR SHPO, in a letter dated April 6, 2024, concurred that a finding of No Historic Properties Affected was appropriate for the proposed undertaking. Previously submitted activities and their related ground disturbances remain as presented initially. However, the submitted project location description has been corrected, and the Scope of Work 4 (SOW-4) has been modified to include the installation of a barbed wire fence around the cropping areas. Consultation is therefore being reinitiated to correct the project location and the revised scope of work 4.

Project Description (Undertaking)

The intended use of funds for the proposed project is the purchase of a plow, sprayer, water tank, electric generator, rotary cutter, tractor, UTV, fencing materials, digging bucket tractor attachment, and the purchase and installation of a new greenhouse.

Ground disturbance activities will be required for the construction of the new greenhouse, the installation of the electric generator, the installation of the water tank, and the preparation of the new plantains and vegetable cropping areas, including the installation of

cropping area delimitation fence. The land was used from 1920 to 1980 for cattle and is currently in use for agricultural purposes with plantain crops. The field is not graded.

The Scope of Work 1 (SOW-1) is the installation of a “High Tunnel” greenhouse at coordinates 18.2194575, -65.7112871. The proposed greenhouse is an approximately 50-foot (ft) x 30 ft galvanized metal structure with six mils plastic membrane and Saran cover to be used for seeding of vegetables, such as culantro, cilantrillo, recao, sweet peppers, and spinach, in tables. The structure includes a rain harvesting system that will be used for the irrigation of vegetable crops. The greenhouse will be anchored to the ground with 2 inches diameter pillars. Greenhouse front and side pillars are reinforced by a ratchet fixed to the ground to a maximum depth of 3 feet and attached to the top of each pillar with Galvanized Cord. Lateral and central pillar spacing varies depending on the greenhouse size. For the proposed greenhouse, the lateral and central pillar spacing is 8 ft. The proposed greenhouse will require up to 22 posts.

The Scope of Work 2 (SOW-2) is the purchase and installation of a 13 KW electric generator at coordinates 18.2192896, -65.7113853. The applicant plans to install the generator on a dike-like system to be constructed on-site. The dike consists of an on-site concrete poured pad of approximately 8 ft x 10 ft and block containment walls of 1 ft of height.

The Scope of Work 3 (SOW-3) is the purchase and installation of a 5,000-gallon water tank at coordinates 18.2193107, -65.7114092. The tank will be installed on a 10 ft x 10 ft poured concrete pad to be constructed. The tank will provide irrigation water to the vegetable crops via an aboveground PVC piping system to be installed.

The Scope of Work 4 (SOW-4) includes the preparation of the new plantains and vegetables cropping areas located at 18.2197820, -65.7121022 (A-plantains crop)/ 18.2191683, -65.7108489 (B-vegetables crop), in areas that appear not to have been previously cultivated. A review of historic aerial imagery failed to identify any evidence of previous cultivation. As previously noted, the area seems to have been utilized for cattle grazing for much of the twentieth century. The activities include the use of the plow, rotary cutter, tractor, and digging bucket tractor. The SOW for the preparation of the cropping areas consists of the installation of wood posts and barbed wire fence (farming materials) to protect and prevent crop damage caused by animal invasion. The fences will be constructed with 3 x 6 ½ wood posts at a depth of 2 feet. At least 900 posts will be installed. The area is planned to be used for the growing of cilantrillo, culantro, coriander, recao, and sweet peppers.

The SOW for the project does not include any power or water utility connection. The rain harvesting system to be installed with the greenhouse will be used as the source of water for the irrigation of the vegetable cropping area via an aboveground PVC distribution system. The project site will require clearing, grading, and vegetation removal. However, the proposal does not contemplate cutting, pruning, or transplanting trees.

Area of Potential Effects

As defined in 36 CFR §800.16(d), the area of potential effects (APE) is the geographic area or areas within which an undertaking may directly or indirectly cause changes in the character or use of historic properties if any such properties exist. Based on this definition and the nature and scope of the Undertaking, the Program has determined that the direct APE for this project is a galvanized metal structure approximately 50 ft x 30 ft (SOW-1), a concrete poured pad of approximately 8 ft x 10 ft (SOW-2), a 10 ft x 10 ft poured concrete pad (SOW-3) and the preparation of the wood fenced cropping areas (SOW-4) as detailed in the Undertaking. A 15-meter buffer has been designated within the SOWs, and the visual APE is the viewshed of the proposed project.

Identification of Historic Properties - Archaeology

Existing information on previously identified historic properties has been reviewed to determine if any such properties are located within the APE of this undertaking. The review of this existing information by a Program contracted Historic Preservation Specialist meeting the Secretary of the Interior's Professional Qualification Standards (36 CFR Part 61), shows there are no documented archaeological sites within a half-mile radius of the proposed project location. A previous cultural resource survey within a half-mile radius reported positive findings concerning the presence of archaeological resources (Table 1). However, a meticulous examination of project findings by Miguel Rodriguez and Virginia Rivera (1987) in the municipality of Naguabo identified only one positive pit (#276) from the historic period, located outside the half-mile radius of the project area. Notably, no other positive test pits were identified within the study area.

The landscape topography and soil characteristics play a pivotal role in determining the likelihood of discovering archaeological sites and the potential for site preservation in a given location. The soil type in the APE is Mabi clay, featuring 5 to 12 percent slopes and erosion (MaC2). This soil type consists of very deep, somewhat poorly drained, and slowly permeable

soils on alluvial fans and terraces of the Humid Coastal Plains of the Major Land Resource Area (MLRA) of Puerto Rico.

These soils have formed in fine-textured sediments of mixed origin. Described as strongly acidic in the A or Ap horizon to moderately alkaline in the Bgss horizons, they are anticipated to have minimal to moderate impact on the preservation of most classes of artifacts and archaeological features. The closest freshwater body is approximately 0.06 mi (0.10 km) of the project area.

The topography, characterized by alluvial terraces susceptible to erosion, combined with the drainage characteristics of the soil, indicates a low to moderate potential for the discovery of new, intact, and well-preserved archaeological sites within the APE.

Identification of Historic Properties - Architecture

Existing information on previously identified historic properties has been reviewed to determine if any such properties are located within the APE of this undertaking. The review of this existing information by a Program contracted Historic Preservation Specialist meeting the Secretary of the Interior's Professional Qualification Standards (36 CFR Part 61), shows that the project area is **not** within the boundaries of a National Register of Historic Places (NRHP)-eligible or listed Traditional Urban Center or Historic District. Additionally, there are **no** NRHP-listed historic properties within the quarter-mile buffer zone from the APE.

The proposed project is located in a rural, flat terrain with mature vegetation and grasslands surrounding the property. The property is located north of Highway-53 Dr. José Celso Barbosa in Naguabo, which runs east-west in this area. A circa 2023 building is located to the east of the APE geocoordinates. This building does not appear on the most recent visible aerial image for the area, the January 2022 Google Earth image shown below. The building was constructed sometime before the date of inspection on 12/14/2023. This building is used as an office and is raised on concrete block foundations. It has wood frame walls with plywood siding and a shed-type corrugated metal roof over the wood frame with overhangs.




Figure 1 & 2. Detail of the January 2022 aerial image of the building on the property and building façade, view to the north.







Re: Justification for the Infeasibility and Impracticability of Radon Testing

After reviewing Application Number PR-RGRW-01875-W under the Regrow Puerto Rico Program, administered by the Puerto Rico Department of Housing (**PRDOH**), to complete the property's contamination analysis in accordance with 24 C.F.R. § 50.3(i) and 24 C.F.R. § 58.5(i), we have determined that testing the property's radon levels is infeasible and impracticable.

Per the U.S. Department of Housing and Urban Development's (**HUD**) CPD Notice 23-103, the recommended best practices and alternative options for radon testing are infeasible and impracticable in this case due to the following reasons:

- As required by the CPD Notice 23-103, the scientific data reviewed in lieu of testing must consist of a minimum of ten documented test results over the previous ten years. If there are less than ten documented results over this

period, it is understood that there is a lack of scientific data. The latest report for radon testing in Puerto Rico was prepared in 1995 by the U.S. Department of the Interior in Cooperation with the U.S. Environmental Protection Agency. No other completed studies and reports on radon testing are available in Puerto Rico.

- There is no available science-based or state-generated information for Puerto Rico for the last ten years that can be used to determine whether the project site is in a high-risk area. The Department of Health and Human Services, Centers for Disease Control and Prevention (**CDC**), National Environmental Public Health Tracking, and Radon Testing map do not include Puerto Rico data.
- There are only two (2) licensed professionals in Puerto Rico who can conduct radon testing using the American National Standards Institute/American Association of Radon Scientists and Technologists (**ANSI/AARST**) testing standards, which makes it difficult, time-consuming, and highly expensive to coordinate and secure a site visit for the contamination evaluation.
- Do-it-yourself (**DIY**) radon test kits are known to be unreliable in assuring and controlling the quality of the test results; they are not readily available in Puerto Rico, and the cost and time required for purchasing and sending them for analysis are unreasonable when weighed against the results' reliability and the need for prompt results.
- Local authorities in Puerto Rico do not have the specialized radon monitoring equipment or trained staff needed to conduct the radon testing analysis and ensure proper quality control and quality assurance practices are adhered to. We also do not have a radiation laboratory certified for radon testing.

As part of the evaluation for this determination, PRDOH sent information requests to six (6) local agencies at the state and federal levels. We received responses from the following agencies:

- United States Geological Survey;
- Centers for Disease Control and Prevention;
- Puerto Rico Department of Health; and
- United States Environmental Protection Agency.

The agencies mentioned above confirmed the lack of scientific data on Radon testing for Puerto Rico and the technical difficulties that we face to comply with HUD's Radon testing requirement. For the above-mentioned reasons, Radon testing is infeasible and impracticable for this property, and no further consideration of Radon is needed for the environmental review.

Thank you for your letter dated October 10, 2024, requesting informal consultation on the above referenced project. As per your request, our comments are provided under the Endangered Species Act (Act) (87 Stat. 884, as amended; 16 United States Code 1531 et seq.), and the Fish and Wildlife Coordination Act (48 Stat. 401, as amended; 16 U.S.C. 661 et seq.).

The Puerto Rico Department of Housing (PRDOH) is proposing various scopes of work (SOW) at Hacienda Grande Neighborhood, Casia Street, Solar 19 in the municipality of Naguabo, Puerto Rico. The proposed SOW consists of the following:

SOW 1: 18°13'09.8"N 65°42'40.3"W

- Installation of a “High Tunnel” greenhouse (50-foot (Ft) x 30-foot) with galvanized metal structure with six mils plastic membrane and saran cover.

SOW 2: 18°13'09.4"N 65°42'41.0"W

- Purchase and installation of a 13KW electric generator.

SOW 3: 18°13'09.5"N 65°42'41.1"W

- Purchase and installation of a 5,000-gallon water tank.
- A 10 Ft x 10 Ft poured concrete pad to be constructed for the installation of the water tank.

SOW 4:

- Preparation of the new plantains (18°13'11.2"N 65°42'43.6"W) and vegetables cropping areas (18°13'09.0"N 65°42'39.1"W).
- The preparation of the cropping areas includes the installation of a wood posts and barb wire fence (farming materials) to protect and prevent crop damage caused by animal invasion. The

fences will be constructed with 3" x 6½' wood posts at a depth of 2 Ft. At least 900 posts will be installed.

Also the activities include the purchase and use of plow, rotary cutter, tractor, 4x4 UTV, sprayer, and the digging bucket tractor. According to PRDOH, the project site will require clearing, grubbing, grading, and some vegetation removal. However, the proposal does not contemplate cutting, pruning, or transplanting of trees.

Using the U.S. Fish and Wildlife Service's (Service) Information for Planning and Consultation (IPaC) system, the PRDOH has determined that the proposed project site is located within the range of the Puerto Rican boa (*Chilabothrus inornatus*).

The Caribbean Determination Key (DKey) in the IPaC application was used to evaluate the potential impacts to federally listed species for this project (Project code: 2024-0148825). Based on the answers provided, a consistency letter was obtained for the Puerto Rican boa, which determined that the proposed actions for this project will have no effect (NE) on this species.

Based on the nature of the project, scope of work, information available, and analysis of the site, PRDOH has determined that the proposed project may affect, but is not likely to adversely affect (NLAA) the Puerto Rican boa instead of the NE obtained by using the DKey. Conservation measures will be implemented in case an encounter with these species occur.

We have reviewed the information provided and our files, and concur with PRDOH's determination that the proposed project may affect, but is not likely to adversely affect the Puerto Rican boa with the implementation of the conservation measures.

In view of this, we believe that requirements of section 7 of the Endangered Species Act (Act) have been satisfied. However, obligations under section 7 of the Act must be reconsidered if: (1) new information reveals impact of this identified action that may affect listed species or critical habitat in a manner that was not previously considered; (2) this action is subsequently modified in a manner not previously considered in this assessment; or, (3) a new species is listed, or critical habitat determined that may be affected by the identified action.

Dear Ms. Medina Smaine,

In the early 1990s the U.S. Geological Survey (USGS) conducted geologic assessments of radon potential for all 50 states and the territories of Guam and Puerto Rico, in collaboration with the U.S. EPA. I conducted the geologic radon potential assessment for Puerto Rico. The PDF file of the report is too large to attach to this message but it can be obtained at <https://pubs.usgs.gov/of/1993/0292k/report.pdf>. The USGS did not conduct indoor radon testing and we did not conduct field studies associated with this assessment; it was based on existing data. Mr. David Saldana of the Puerto Rico Department of Health kindly provided us with data for 610 homes that were tested for indoor radon by his agency between 1993 and 1995, which are summarized in the report. I am not aware of any other radon-related geologic studies conducted in the Commonwealth of Puerto Rico by the U.S. Geological Survey.

Dear Honorable Secretary Rodriguez Rodriguez:

This communication is in response to your letter of August 20, 2024 addressed to the Puerto Rico Department of Natural and Environmental Resources (DNER) and referred to the U.S. Environmental Protection Agency (EPA) regarding available data on radon testing and levels within Puerto Rico.

EPA's National Radon Action Plan 2021–2025 sets a goal for the nation to find, fix and prevent high indoor radon levels in 8 million buildings by 2025 and prevent 3,500 lung cancer deaths per year. Under this Plan, leaders from across multiple sectors are working together to plan, guide, and sustain nationwide action to prevent exposure to radon.

Due to the lack of data in Puerto Rico, EPA undertook an investigation in collaboration with the University of Puerto Rico-Mayaguez (UPRM) Campus, Departments of Civil Engineering and Surveying and Mechanical Engineering, to find out if radon presented a problem in Puerto Rico. Up until 2021, the only data we had for Puerto Rico was a 1993-1995 mail-in radon screening study referred to by the U.S. Geological Survey report (USGS, 1995) in which the USGS concluded that several areas of Puerto Rico have the geologic potential to generate indoor radon levels exceeding the EPA Action Level of 4 pCi/L (picocuries per liter), perhaps locally reaching very high levels above 50 pCi/L, if a house construction and

ventilation allow for soil-gas radon to enter and concentrate within the structure.¹ According to the USGS report, most of these areas are located in the northwest part of the island. Please note that the actual 1993-1995 study documentation is not available to the EPA.

Typical radon testing technology used in mainland United States (charcoal canisters or electric-powered devices) are impractical in Puerto Rico because of high humidity and power outages. The recovery and rebuilding of communities following the aftermath of 2017 Hurricanes Irma and Maria presented an opportunity to develop radon prevention and mitigation strategies in 2019. Initially, EPA sampled indoor radon air in over 170 single-family residences in the municipalities of San Sebastian, Lares, Ciales, Arecibo, Morovis, Camuy, and Hatillo and later expanded the project to other municipalities such as Rincon, Aguada, Aguadilla, Isabela, Quebradillas, Barceloneta and Vega Baja. The quality assurance protocols were anchored in American National Standards Institute/American Association of Radon Scientists and Technologists (ANSI/AARST) standards of practice (ANSI/AARS, 2019). The sampling was designed in two stages: scoping and confirmatory sampling. The scoping sampling was conducted using Corentium Home (CH) electronic monitors and E-Perm systems. Locations measuring above the EPA Action Level of 4 pCi/L with CH were measured at the second stage of the sampling using RAD7 and Corentium Pro Continuous Radon Monitors (CRMs). Nationally certified radon sampling professionals led by one such professional from the UPRM conducted confirmatory sampling in the second stage. Also, during the study, the nationally certified radon mitigation professionals inspected several homes with elevated indoor radon levels.

Mapping radon in Puerto Rico proved to be a complicated endeavor given the COVID-19 pandemic in 2020. EPA and UPRM continue to work on the project, however, results have not been finalized, and no scientific report has been published yet. Unfortunately, EPA cannot share preliminary data at this time because it contains privileged information. Nevertheless, preliminary data from the study does show homes with levels over 4 pCi/L (EPA Action Level) that might need mitigation to protect the health of their inhabitants.

Although many states have developed laws and regulations governing radon disclosure, certification, and mitigation, Puerto Rico lacks legislation or mandatory radon testing provisions for new construction, remodeling, selling or buying homes. Given this loophole and aiming to answer your request, the EPA can provide information on Best Management Practices for sampling indoor radon in Puerto Rico.





**Figure 6: ADVISORY BASE FLOOD ELEVATION


Figure 2: AIRPORT ZONES






Figure 12: FARMLAND PROTECTION






Figure 14: WETLANDS


