The Funding Opportunity Description under the Funding Announcement Summary of the NOFA is hereby revised to read as follows and such changes shall be considered by Applicants:

"Funding Opportunity Description: In accordance with the PRDOH Action Plan, as amended, the SBIA Program was assigned thirty five million dollars (\$35,000,000) of CDBG-DR funds and currently has nine million dollars (\$9,000,000) in available funds. However, because funds are provided through various allocations as detailed in the Action Plan approved by HUD, availability is subject to HUD's release of such funds. PRDOH reserves the right to award selected Applicants in accordance with funds made available by HUD and based on any applicable statutory constraint at the time of award issuance. Under the conditions of this NOFA, it is the intent of PRDOH to award grant funds to eligible incubator and/or accelerator firm Applicants in an individual award amount not to exceed two million five hundred thousand dollars (\$2,500,000).

Provided, that if the date on which the copy of the notice is filed in the records of the PRDOH differs from the mailing date of said notice, the aforementioned twenty (20) calendar day-term shall be calculated from the mailing date.
