This Addendum to the NOFA contains revisions to the Eligible Applicants Section and the Schedule Section contained thereunder. Such revisions are being issued to provide clarification that Units of local government (Municipal Governments) are Eligible Applicants of the SBIA Program in accordance with the PRDOH CDBG-DR Action Plan and the Schedule Section is revised as a result thereof.

#### Amendments to NOFA

Section 3.2, Eligible Applicants, of the NOFA is hereby revised to read as follows and such changes shall be considered by Applicants:

### "3.2 Eligible Applicants

Eligible entities for the SBIA Program include:

- NGO (501(c)(3)) or Not for Profit Entities
- Community Based Development Organizations
- Public Institution of Higher Learning (e.g. Universities)
- Administrative Agency or Department of Government of Puerto Rico (State Agencies)
- Units of local government (Municipal Governments)
- For Profit Entities as authorized under 24 C.F.R. § 570.201(o)
  - o private higher education institution would only be eligible if it complies with § 570.201(o) or if it's a (501(c)(3)) or not for Profit Entities. (501(c)(3)) should be eligible provided its program meets the rest of criteria outlined in the NOFA.
